

HERITAGE PARK NEIGHBORHOOD UPDATE

JULY 8, 2024

Now that the town of West Hartford has approved the Residences at Heritage Park, on 1700 Asylum Ave., the public review process for the apartments, townhomes and mixed-use features on the 1800 Asylum Ave. side is underway.

Each step in the public review process by West Hartford town staff, the Design Review Advisory Committee (DRAC), the Inland Wetlands & Watercourses Agency (IWWA) and the Town Plan & Zoning (TPZ) Commission has helped improve the design and character of the project.

The revised plans will provide a nature-focused experience for the residences, shops and other businesses that we hope to bring to the campus village.

- We have reduced the number and size of the townhouses along Asylum Ave. and Lawler Rd. so that they are more in scale with the homes across both streets.
- We have repositioned and reduced the size and layout of the assisted living facility to draw it away from wetlands and shrink the number of parking spaces.
- A comprehensive mitigation plan will create new wetlands, restore developed lawn wetlands, enhance riparian corridors, enhance developed lawn upland buffers and establish a wetland walking trail with interactive signage.
- We have increased the wetland buffer enhancement areas and reduced potential disturbances in the upland review areas by narrowing driveways and introducing permeable pavers where possible.
- The site will have public walking trails designed to invite people who live in the surrounding neighborhoods to utilize the park-like setting.
- The interior village drive now aligns with Fox Meadow Lane on Asylum Ave. We plan to have sufficient parking
 on site so neighbors are not bothered by people parking on their streets. It is our priority to properly address
 that—and all traffic concerns that might arise—in conjunction with an OSTA (Office of the State Traffic
 Administration) review and approval.

We will be presenting these plans at a public hearing before the IWWA on Wednesday, July 17. Only after a decision on that application will we finalize plans and submit to the West Hartford Town Council for consideration of our formal village development proposal.

A small, vibrant village and a great place to live

Our goal is to give West Hartford residents new options to live here in this welcoming, green, walkable village that will fit well into this location—a place where people in the new village and area neighborhood will be able to walk from their homes to the grocery store, enjoy the day spa, grab coffee, lunch or dinner, visit the small shops, use the walking trails or relax by the waterside.
